115/24 ROAD SAFETY ISSUES –

Southam Street, Warwick Road, King John s Road and Banbury Road

Banbury Road: still awaiting the H bars as agreed.

Southam Street: having liaised with Safer Neighbourhood Team, whilst the team can visit the site and will enforce any offences witnessed, it is clearly within the rights of the public to use the road -if they do so within the law. See also the Chair's Report item ii.

King John's Road: CCllr Mills reported that he will contact Carol Hooper and Margaret Pollard with an update on the primary school entrance.

There followed a brief discussion about poor driving and how the community can assist the police, as well reporting incidents / gathering footage etc. It was suggested there may be opportunities to support 'driver education' by inviting the Safer Neighbourhood Team to attend community events to provide engagement/awareness activities on driver-related issues.
